AZEUS APPOINTS NEW EXECUTIVE VICE PRESIDENT

He also served at IBM Greater China Group as its Chief IT Architect, where he built the e-business Solutions team from two persons to 130 persons within a year. Under Mr Wong's leadership and management, his team achieved over US\$20 million worth of e-business projects in the government sector as well as the banking and finance industry. With his depth of managerial and sales experience, Mr Wong moved on to become the Chief Technology Officer and Managing Director of Star East, a listed entertainment company, where he managed a 120-person global engineering and sales team.
