## AZEUS ENTERS INTO GOVERNMENT SERVICE CONTRACT WORTH A TOTAL ONE-OFF PRICE OF APPROXIMATELY HK\$9.8 MILLION (EQUIVALENT TO APPROXIMATELY US\$1.3 MILLION<sup>1</sup>)

*Singapore, January 25, 2013* – Azeus Systems Holdings Ltd. ("Azeus" or the "Group"), a provider of IT consultancy services based in Hong Kong, today announced that Azeus Systems Limited, a wholly-owned subsidiary of Azeus has entered into a service contract worth a total one-off price of approximately HK\$9.8 million (equivalent to approximately US\$1.3 million<sup>1</sup>) with the Government of the Hong Kong Special Administrative Region ("Hong Kong Government").

Said Mr Lee Wan Lik, Managing Director of Azeus, "We are pleased to enter into this service contract to redevelop the Civil Division Case Management System for the Hong Kong Government. Since our establishment in 1991, we have achieved a solid track record of over 100 projects, many of which are with government departments. We believe that our commitment and proven ability to deliver high quality solutions distinguishes us in Hong Kong's competitive landscape."

The service contract, which is for the redevelopment of the Civil Division Case Management System for the Department of Justice, Hong Kong Government, is expected to commence in February 2013 for a period of 24 months.
