AZEUS SECURES TENDER TO PROVIDE IT SERVICES TO HONG KONG GOVERNMENT DEPARTMENTS FOR A FOURTH CONSECUTIVE TERM

Singapore, August 22, 2013 – Azeus Systems Holdings Ltd.
